2027 Propel Scholarship

Applications are currently open for the 2027 Propel: Australian Submarine Scholarship Program.

The Propel program provides access to activities and opportunities designed to connect students to the AUKUS Nuclear-Powered Submarine Pathway including:

- A scholarship
- Connections to study and career opportunities
- Access to technical workshops and events
- Access to people, organisations and broader networks in Defence and Defence Industry

Before completing an application for the Propel: Australian Submarine Scholarships program, please ensure that you have reviewed the Propel Application Guidelines. It is the responsibility of the applicant to ensure they are eligible to apply for the program. All application questions must be answered unless (optional) appears next to the question.

The confidentiality of applicants and their responses is of paramount importance. The information included in eligible applications will be used to determine applicants' suitability for Propel scholarships. Personal information including the name, descriptions of gender identity and address of the applicant will not be provided to the assessors. The information linked to the applicant's name will only be accessed by ATSE.

Applications for the 2027 Propel scholarship program close at 11:59am (AEST) on 2 October 2026.
